BCMA Medical Student Summer Intern Project:

The medical student who participates in this summer intern program will gain valuable first-hand experience working at their medical association. The Medical Student Intern will be working on a project within the strategic scope of the association's work.

Medical Student Survey Project

Working in the Corporate Affairs Insurance department, you will create and conduct a survey for UBC medical students. You will report on how students perceive the BCMA and medical associations in general, how they prefer to communicate, how best to capture their interest, their attitudes towards insurance, and what benefit and insurance programs would be useful to them. The BCMA's goal is to ensure that student members' needs and interests are being addressed.

The intern will also help BCMA create and execute a plan to promote programs throughout the year. For example, the intern can create a BCMA Student newsletter that will help students understand the benefits of their association.

Requirements:

- Must currently be a UBC 1st or 2nd year medical student in good standing;
- Exceptional verbal and written communication and research skills;
- Excellent computer skills (Word, Excel, PowerPoint, and Medical database search).

- Resume and cover letter explaining why you are interested in this opportunity;
- Indicate in 500 words or less why you are interested in this project and what would make you best suited for it.
